BRAC's ground-breaking ultra-poor graduation programme has graduated more than 2 million households out of the direct forms of poverty and social deprivation and has inspired the global uptake of the 'graduation approach' to tackle extreme poverty.

Shameran also chairs the board of BRAC Bank's mobile financial services subsidiary, bKash, and serves on the boards of several institutions including BRAC UK, BRAC IT Services Ltd and the Global Alliance for Banking on Values (GABV). Additionally, he is the chairman of the Microfinance Network and is also a member of the Partnership for Responsible Financial Inclusion (PRFI) and the World Economic Forum Financial Inclusion Steering Committee. He also serves on the global advisory board of Pinbox Solutions, a global social enterprise committed to digital micro Pension inclusion in developing countries.
