Conferences

International Conference on Political Economy, Accountability and Governance held

A three-day International Conference on Political Economy, Accountability and Governance was held at Dhaka from 11th-13th December, 2014. The event was organised by BRAC Institute of Governance and Development (BIGD), BRAC University, in partnership with Think Tank Initiative (TTI) of International Development Research Centre (IDRC), International Growth Centre (IGC) of London School of Economics (LSE) and Effective States and Inclusive Development (ESID) of the University of Manchester.

Dr. Masihur Rahman, Honourable Economic Affairs Adviser to the Prime Minister, inaugurated the conference while H.E. Brian Allemekinders, Charge d'affaires, Canadian High Commission in Dhaka, attended as the Special Guest of the ceremony.

While inaugurating Dr. Masihur said, the concepts of governance and political economy are very inclusive and diverse in nature, and that the scope of their studies has expanded immensely over the years. He emphasised on technical and methodological rigor of research before any policy recommendation is made. He agreed that the concept of governance has replaced that of government. While government is more concrete, governance is more inclusive. He urged those who participate in the debate and discourse on policy to show a certain sense of responsibility and to engage in constructive criticism of the government.

H.E. Brian Allemekinders said democracy is much more than mere elections; it requires an independent judiciary and election commission and space for mass media. There cannot be true good governance without true representation, and true development is not possible without good governance, he explained.

"For Bangladesh to move forward, confrontational politics must diminish. The trend of politicising institutions must decrease. For this to happen, citizens will have to ask for it and demand it and hold your government and political parties accountable," he added.

Earlier, Dr. Sultan Hafeez Rahman, Executive Director, BIGD; Dr. Syed Saad Andaleeb, Vice Chancellor, BRAC University and Ms. Julia Brunt, ESID welcomed the distinguished guests and the participants at the inauguration of the international conference.



In the inaugural panel titled, Whither Governance in South Asia?, Prof. Kunal Sen, ESID and Prof. Wahiduddin Mahmud, Member of the former Caretaker Government presented two separate papers titled, 'Governance and Development Outcomes in Asia' and 'Bangladesh: The Limits of a Developmental Welfare State under Governance Dysfunction' respectively. Prof. Mushtaq Khan of School of Oriental and African Studies (SOAS) of University of London; Dr. Sanjay Kumar, Director of Centre for the Study of Developing Societies (CSDS), Delhi, and Dr. Sultan Hafeez Rahman were the panelists, and Professor Rehman Sobhan, Chairman, Centre for Policy Dialogue (CPD) chaired the session.

Prof. Wahiduddin Mahmud said, Bangladesh has the image of a developmental welfare state, as reflected in the country's Constitution and in numerous other official documents, but the country has to contend with a serious problem of dysfunctional governance. According to Prof. Mahmud, although there was a transition from an authoritarian rule to parliamentary democracy in 1991, the political culture is one that does not allow democratic practices to flourish or one that can hardly deliver accountable and transparent governance.

Prof. Wahiduddin Mahmud in his paper tried to explain the paradox in terms of nature of development interventions and the underlying political incentives and accountability mechanism.

"The core government system is characterised by a dysfunctional parliament, highly confrontational politics, absence of democratic practices within the major parties, polarisation of the state institutions and a corrupt and inefficient bureaucracy," said Prof. Mahmud. Consequences of this extremely weak governance structure and non-existent accountability mechanism are most acute in the spheres of public provisioning of services, he added.

Prof. Mushtaq Khan, from SOAS argued that democracy is not essential to increase the economic growth, but is crucial for political stability of a country. He also argued that a country could grow economically despite widespread corruption. In this connection he gave example of the Indian state of Tamil Nadu.

Commenting on findings of the speakers, participant Prof. Ataur Rahman, President of Bangladesh Political Scientists Association said, there were syndromes that Bangladesh has turned into a one party state in the absence proper function by the election commission and anti-corruption commission.

Noted economist Professor M.M. Akash of Dhaka University said, while the wealthy people mostly spend their money either on 'wasteful' luxury or siphon it out of the country instead of investing in the domestic economy, the contributions of the poorer sections are driving growth. He added, despite bad governance and the acts of the rich, Bangladesh's economy is growing for farmers, expatriate wage earners, garment workers, and small and medium entrepreneurs.

Former Minister M.K. Anwar pointed out lack of serious civic rights under the present government.

In the three-day conference, 29 papers were presented in a total of nine sessions titled, Whither Governance in South Asia?; State Institutions and Policy Choices; the Political Dynamics of Economic Growth; Institutional Performance and Growth; Political and Institutional Reforms; Institutions for Sustainable Development; Social Provisioning, Education and Health; Political Economy of Incentives; and Corruption and Institutions.

44 economists, social and political scientists from USA, UK, Japan, India, Nepal and Bangladesh participated in the conference. At the concluding day, the participants agreed that good governance is not a requisite for development. However, smart implementation of policies and programmes, enhanced infrastructural development and effective functioning of democratic institutions must be taken care of in order to achieve higher economic growth. Moreover, electoral and political reforms, avoiding confrontational politics, free and fair justice delivery system, strengthening institutions are needed to boost economic growth, which will help to establish a working democracy.

The Speakers analysed the relation among economic growth and inequality, political institutions and accountability, politics of recognition, social provisioning and inclusive governance, decentralisation and local governance, sustainable urban growth,

poverty alleviation and democratic governance in their papers in the conference. The conference comprised presentations of empirical research, especially evidence based.

In the concluding session, BIGD Executive Director Dr. Sultan Hafeez Rahman said, 'Bangladesh should turn the large human capital into skilled, experience-based

knowledge capital and engage them to accelerate the economic growth to the next level.' He thanked the participants saying, 'Knowledge should be nurtured collectively and that's why the conference has been organised.' He acknowledged the support of BIGD's partners - ESID, Univ. of Manchester, IGC and TTI under IDRC - in organising the conference.

Dr. Sultan Hafeez Rahman, the Executive Director of BIGD chaired the event, attended by dozens of academicians, civil society members, foreign delegates, journalists and students. The objective of the lectures was building awareness on Chinese experience in poverty reduction and women development. Reformation in rural and agriculture sectors, an exportoriented production strategy and special focus on poverty reduction were the key components enabling the development of the Chinese economy, revealed two Chinese academicians at the lecture.

Prof Zuo Ting said, around 46 percent of the populations of 1,360 million live in rural areas of China. The government's priority on health, education, infrastructure and agriculture has played a signification role in rural development, he said while delivering a public lecture on 'China's Experiences in Rural Development.'

Another lecture was provided by Prof Wang Libin, head of the College's International Students Department. In her lecture 'Gender Mainstreaming in Poverty Reduction Programme-Experience of China,' Prof Wang Libin talked about women and gender issues of China.

Seminar on Increasing Tax Compliance through Social Recognition held in Bangladesh

BRAC Institute of Governance and Development (BIGD), BRAC University and International Growth Centre (IGC) jointly organised a dissemination Seminar on 'Increasing Tax Compliance through Social Recognition in Bangladesh' by Mushfiq Mobarak, Associate Professor of Yale School of Management, on 5th November 2014, at Dhaka.

The study rigorously evaluates the impact of these programmes on tax payments. In neighbourhoods, where some firms are complaint, the promise of exposing information about all firms' tax payment behavior led to a positive response and an increase in tax compliance, especially among firms who had not paid the previous year. In high compliance clusters, firms receiving the peer information treatment were not only more likely to pay, but conditional on paying, paid more than firms not receiving this treatment. Combining these two effects, firms receiving the peer information treatment paid 17% more on average during the study period than other firms.

The results suggest that social incentives and recognition may be an effective way to improve tax compliance and has led to quantitatively meaningful increase in total revenues. The treatments tested consist of interventions that governments could implement on a large scale which in turn may lead to significant improvement in tax compliance and revenue collection.

Dr. Sultan Hafeez Rahman, Country Director, IGC Bangladesh, and Executive Director, BIGD, chaired the event. Mr. Magnus Schmid, Program Coordinator, PSES, GIZ, gave opening remarks at the seminar.

The event focused on productivity issues and gender biases inside the garment industry. While the RMG sector was the first industry to provide large scale employment opportunities to women, few of the jobs have been at the management level. As today, around 85 percent of machine operators in the sector are female, while managers are overwhelmingly male.

Dr. Sultan Hafeez Rahman, Director of IGC Bangladesh Programme and Executive Director at BIGD, highlighted the importance and the complexity of such a research project, the first on the garment industry to be so data rich and detailed in the design. Dr.Rahman also commented the crucial role of IGC in funding, supporting and connecting policy oriented economic research, such as this project, to influential policy makers.

BIGD Launched

The State of Governance Bangladesh 2013: Democracy Party Politics Report

The annual flagship research report of BRAC Institute of Governance and Development (BIGD), BRAC University, titled 'The State of Governance Bangladesh 2013: Democracy Party Politics,' was launched on 20th December 2014, at the BRAC Centre Inn Auditorium, Mohakhali, Dhaka, in a huge gathering of journalists, academicians and researchers, policy-makers, civil society members, politicians and concerned others.

Renowned jurist with international reputation and one of the composers of the Bangladesh Constitution Dr. Kamal Hossain, was the Chief Guest of the ceremony. Advocate Suranjit Sengupta MP, senior leader of ruling Bangladesh Awami League and Chairman of the Parliamentary Standing Committee on the Ministry of Law, Justice & Parliamentary Affairs; Advocate Yusuf Hossain Humayun, Advisory Council Member of Awami League; Mr. Amir Khosru Mahmud Chowdhury, Advisor to the Chairperson of Bangladesh Nationalist Party (BNP) and former Minister; attended the event as Guest Speakers. Dr. Binayak Sen, Research Director of Bangladesh Institute of Development Studies (BIDS) and Dr. Imtiaz Ahmed, Professor of International Relations, University of Dhaka, were the designated discussants on the report. Dr. Sultan Hafeez Rahman, the Executive Director of BIGD presided over the programme.

Dr. Minhaj Mahmud, Head of Research of the Institute, shed lights on the key findings of the report, which shows that the progress in achieving three key elements — state building, democratic accountability and the rule of law — are constrained in Bangladesh by the overwhelming influence wielded by the two dominant political parties who have ruled the country for much of their existence, over state and non-state institutions.

'Such near-complete dominance over the various state and non-state institutions by the political parties has led to a political system which may be described as partyarchy,' the report added. The report said political violence increased at a constant rate of 4 per cent compared to the previous years. 'The ruling parties' endemic propensity to engage in political violence surpasses that of the opposition parties,' he added. Quoting a report of Maplecroft, the study said Bangladesh was ranked 21st high risk country for political violence in the Conflict and Political Violence Index 2013. The report also said rudimentary democratic practices were absent at the grassroots level of the two main parties, which further diminished the prospects of democratic consolidation.

The report concluded that the norms and practices of the two dominant political parties had severely constrained the establishment of a modern and constitutional democracy, and their political conduct posed major risks to reversal of the gains achieved through the democratic process.

The report also stressed the need for an enlightened social contract or national compact in which narrow party interests would be subordinated to national interests for consolidating democracy and suggested an enlightened national dialogue on the future political directions.

Dr. Imtiaz Ahmed said, the spectre of liberal fascism is haunting the country, and what exists here is electoral authoritarianism. He highlighted how bad governance sometimes becomes profitable pushing good governance to the back seat. "I do not think any political party alone will be able to do that. It is the structures that need to evolve to make good governance profitable," he added.

Dr. Binayak Sen said, ineffective democracy could not march with the economic development. "If there is lack of good governance, development cannot take place. Since the country is developing, it can be said that good governance is prevailing." He humbly made 3 requests. These are: to the government to initiate a dialogue, BNP to leave Bangladesh Jamaat-e-Islami and Jamaat to leave its leaders accused of 1971 war crimes.

Advocate Yusuf Hossain Humayun said, if there is to be any dialogue, the BNP has to come up with issues of national interests, not with any conditions.

Mr. Amir Khosru Mahmud Chowdhury said a representative government was a must for any country along with a multi-party democracy. "But a representative government is absent in the country. Space is required for democracy to sustain, but due to state-sponsored terrorism, no space was given to any party", he added.

Dr. Kamal Hossain said dialogue should not only be held between the Awami League and the BNP but also among all the parties and concerned others. Accepting the basic principles of the Constitution, all should sit for talks. He further added, democracy must be brought out of the 'partyarchy' to make it 'effective,' and urged the political parties to sit together to work out a solution to the end.

Asserting that the country was passing through an abnormal time, speakers at the launching said election

was not the last word for upholding democracy. Dialogue was a must to overcome any political crisis. However, as a prerequisite to that, effective democratic institutions should be set up, they opined.

The programme participants also said economic and political development should march together and political parties must do away with the culture of blamegame.

Dr. Sultan Hafeez Rahman, in his concluding remarks, said despite economic progress, Bangladesh's democratic development has been hampered. It is a matter of serious frustration for the public. He also added, though the democratic development is in crisis globally, but it doesn't mean Bangladesh has any scope for complacency, as "such underdevelopment," poses serious risks for the future.

Experts of relevant field, eminent professionals and representatives from various academic and research institutions, government, NGOs, donor agencies, international organisations; civil society members, politicians and senior journalists attended the programme. There were huge interests of participating in the open discussion session of the event. At least ten participants made their comments, remarks and suggestions on issues of the report.
